1. Policies

1.1 According to journal type


- 1.1.1 The article should be published in a journal belonging to the Journal Citation Report list (JCR white list), while not belonging to the black list (predatory editors Bealls list)
- 1.1.2 Impact factor (IF) of journals is considered, taking into account the fact that different specialties journals have different impact factors. Therefore, greater consideration is given to those papers published in the top percentile IF journals in a given specialty (according to the Scientific Journal Rankings (SJR) quartiles).
- 1.1.3 Publications in journals of IF=0 will NOT BE CONSIDERED.

1.2 According to publication type

- 1.2.1 A peer reviewed publication is considered to be an original article or a systematic review/meta-analysis; it does not include abstracts or replies to letters or case reports (exceptional situations may however be considered).
- 1.2.2 Editorship/authorship of authoritative textbook will be considered; the book should be published by a known international or academic publisher.
- 1.2.3 Also considered, but to a lesser degree, are narrative reviews, case reports or small case series (< 3 patients) or similar smaller reports, authoritative letters to the Editor and the like, particularly if published in high impact factors journals.
- 1.2.4 WILL NOT BE CONSIDERED:
 - a. Editor/author of self- published book
 - b. Non peer reviewed articles
 - c. Abstracts or replies to letters or ordinary case reports

1.3 According to authorship

- 1.3.1 The author presenting for promotion should be the first, corresponding or last author.
- 1.3.2 Middle authorship on major impact papers (e.g. randomized trials) is equally considered.
- 1.3.3 Second authorship is also considered, but to a lesser degree.
